
#### **TEST CIRCUIT 2 SWITCHING TIME**




#### **TEST CIRCUIT 3 GATE CHARGE**



#### TYPICAL CHARACTERISTICS (TA = 25°C)






#### FORWARD BIAS SAFE OPERATING AREA





#### TRANSIENT THERMAL RESISTANCE vs. PULSE WIDTH




#### FORWARD TRANSFER CHARACTERISTICS




V<sub>GS</sub> - Gate to Source Voltage - V

#### GATE TO SOURCE THRESHOLD VOLTAGE vs. CHANNEL TEMPERATURE


VDS - Drain to Source Voltage - V




FORWARD TRANSFER ADMITTANCE vs. **DRAIN CURRENT** 



DRAIN TO SOURCE ON-STATE RESISTANCE vs. DRAIN CURRENT




DRAIN TO SOURCE ON-STATE RESISTANCE vs. GATE TO SOURCE VOLTAGE





















#### PACKAGE DRAWING (Unit: mm)
